AQUAHEAT SOLAR panels carry a **10 year walk in warranty**. AQUAHEAT SOLAR will repair and if not repairable, replace your solar panel at the AQUAHEAT SOLAR warehouse in Cape Town or Gauteng.

No amendments or additions to the warranty shall be binding on AQUAHEAT SOLAR.

This warranty explicitly covers the above mentioned products only. This warranty does not cover part or parts of the installation, or transportation, which may as a consequence of the failure or defect of solar panel, become damaged in any way whatsoever, and in no circumstances shall AQUAHEAT SOLAR be liable for any direct or consequential loss suffered by the customer and/or third party. This warranty is applicable under the following conditions:

1. The period of the warranty is calculated from the date of installation, provided that the documentation of the proof of installation is furnished otherwise from the date of purchase.
2. This shall be deemed to be the commencement date of the warranty period.

A Copy of this warranty must be submitted to AQUAHEAT SOLAR, in order to register your warranty. Failure to do so will result in the warranty to be nulled. It is the responsibility of the buyer to ensure that AQUAHEAT SOLAR receive the copy of this warranty. AQUAHEAT SOLAR will confirm receipt of completed warranty via email.
